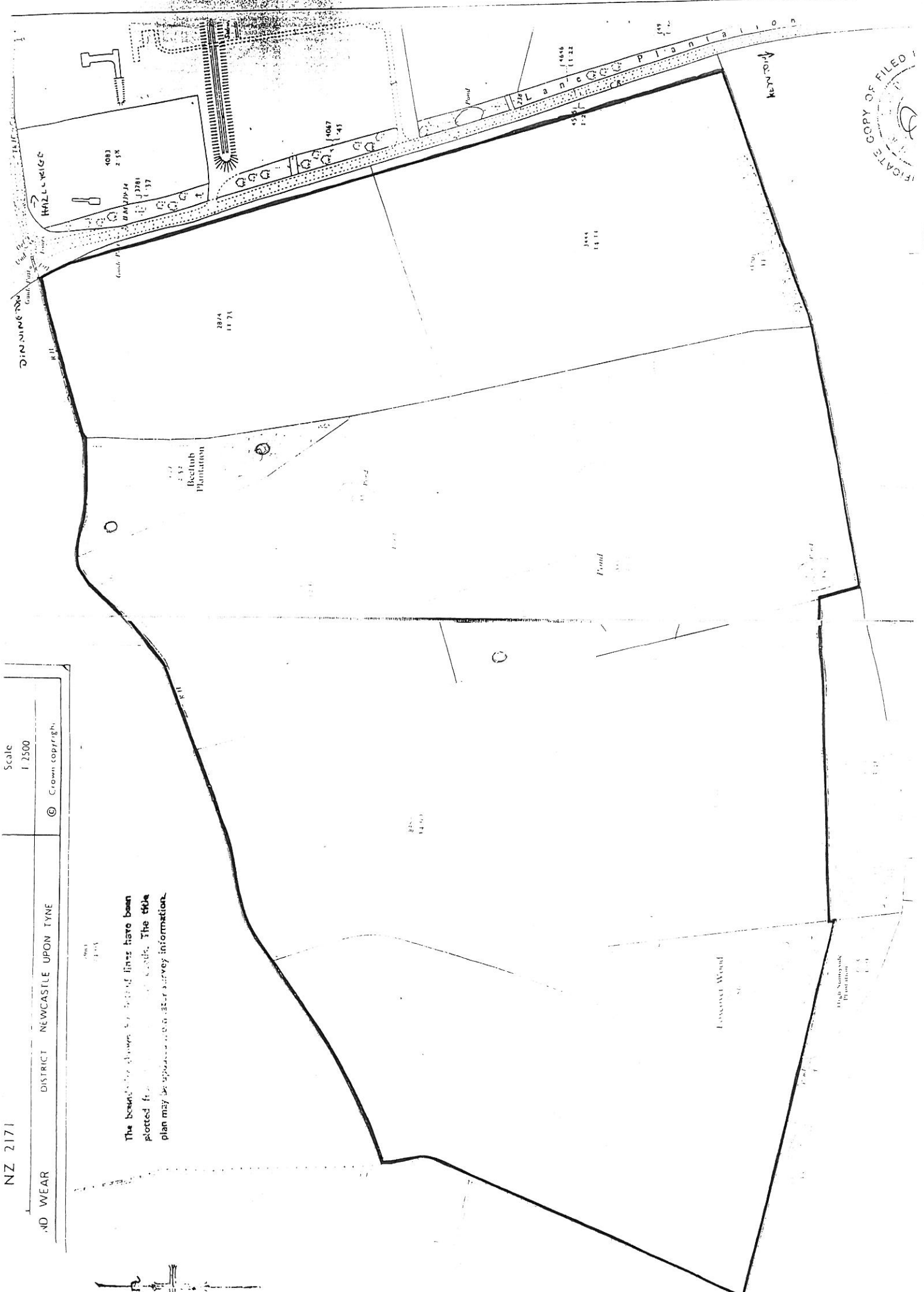

STATUTORY DECLARATION
