
STATUTORY DECLARATION
SECTION 31(6) OF THE HIGHWAYS ACT 1980

1. We The Most Noble Ralph George Algernon Twelfth Duke of Northumberland The Honourable James William Eustace Percy and The Right Honourable Matthew White Fifth Viscount Ridley in our capacity as Trustees and Statutory Owners under the Settled Land Act 1925 of the Tenth Duke of Northumberland's Settlement dated 19th April 1972 are the owners of land within the administrative area of the Newcastle upon Tyne City Council referred to below
2. On or about 6 March 2013 we deposited with Newcastle upon Tyne City Council being the appropriate Council a Statement dated 6 March 2013 which:-
 - (a) was accompanied by a plan showing edged red the land vested in us within the administrative area of the Newcastle City Council; and
 - (b) stated that:-
 - (i) the footpath coloured yellow on the said plan had been dedicated as a public footpath and
 - (ii) the bridleways coloured green on the said plan had been dedicated as public bridleways
3. No additional ways have been dedicated over that land shown edged red on the plan accompanying this Statutory Declaration now produced and shown to us marked 'Plan 1' since the said Statement referred to in paragraph 2 above


